Equality Impact Assessment - Policy Review

In reviewing this policy, we have tried to make a positive impact on equality by considering and reducing or removing inequalities and barriers which already existed. We have ensured that this policy does not impact negatively on the dimensions of equality.

1 Aims

- 1.1 The General Data Protection Regulation (GDPR) aims to protect the rights of individuals about whom data is obtained, stored, processed or supplied and requires that organisations take appropriate security measures against unauthorised access, alteration, disclosure or destruction of personal data.
- 1.2 The Trust is dedicated to ensure the security of all information that it holds and implements the highest standards of information security in order to achieve this. This document sets out the measures taken by the Trust to achieve this, including to:
 - protect against potential breaches of confidentiality;
 - ensure that all information assets and IT facilities are protected against damage, loss or misuse;
 - support our General Data Protection Regulation Policy in ensuring all staff are aware of, and comply with, UK law and our own procedures applying to the processing of data;
 - increase awareness and understanding within the Trust of the requirements of information security and the responsibility of staff to protect the confidentiality and integrity of the information that they themselves handle.

2 Introduction

- 2.1 Information security can be defined as the protection of information and information systems from unauthorised access, use, disclosure, disruption, modification or destruction. Staff are referred to the General Data Protection Regulation policy and the Acceptable Use of IT agreement for further information. These are designed to protect personal data and can be found in the staff shared drives in individual schools.
- 2.2 For the avoidance of doubt, the term 'mobile devices' used in this policy refers to any removable media or mobile device that can store data. This includes, but is not limited to, laptops, tablets, digital cameras, memory sticks and smartphones.

3 Scope

- 3.1 The information covered by this policy includes all written, spoken and electronic information held, used or transmitted by, or on behalf of, the Trust, in whatever media. This includes information held on computer systems, paper records, hand-held devices and information transmitted orally.
- 3.2 This policy applies to all members of staff, including temporary workers, other contractors, volunteers, trainee teachers, supply staff, governors/trustees and all third parties authorised to use the IT systems.
- 3.3 All members of staff are required to familiarise themselves with its content and comply with the provisions contained within it. Breach of this policy will be treated as a disciplinary offence which may result in disciplinary action under the Trust's Disciplinary policy, up to and including summary dismissal depending on the seriousness of the breach.
- 3.4 This policy does not form part of any individual's terms and conditions of employment with the Trust and is not intended to have contractual effect. Changes to data protection legislation will be monitored and further amendments may be required to this policy in order to remain compliant with legal obligations.

4 General principles

- 4.1 All data stored on our IT systems are to be classified appropriately (including, but not limited to, personal data, sensitive personal data and confidential information. Further details on the categories of data can be found in the Trust's General Data Protection Regulation policy). All data so classified must be handled appropriately in accordance with its classification.

- 4.2 Staff should consult the Data Protection Officer (DPO) if they are unsure of the appropriate security arrangements for the type of information they access in the course of their work. All data stored on our IT systems and our paper records shall be available only to members of staff with legitimate need for access and shall be protected against unauthorised access and/or processing and against loss and/or corruption.
- 4.3 All IT systems are to be installed, maintained, serviced, repaired and upgraded by the Trust or school ICT team or by such third party/parties as the Chief Executive Officer or Chief Financial Officer may authorise.
- 4.4 The responsibility for the security and integrity of all IT systems and the data stored thereon (including, but not limited to, the security, integrity and confidentiality of that data) lies with the Chief Executive Officer, supported by the Trust's Network Manager and individual school's Network Manager, unless expressly stated otherwise.
- 4.5 All staff have an obligation to report actual and potential data protection compliance failures to the DPO who shall investigate the breach (full details of the officer can be found in the Trust's General Data Protection Regulation policy).

5 Physical security and procedures

- 5.1 Paper records and documents containing personal information, sensitive personal information, and confidential information shall be positioned in a way to avoid them being viewed by people passing by as much as possible, eg through windows. At the end of the working day, or when staff leave their desk unoccupied, all paper documents shall be securely locked away to avoid unauthorised access.
- 5.2 Available locked filing cabinets and locked cupboards shall be used to store paper records when not in use.
- 5.3 Paper documents containing confidential information should not be left on office and classroom desks, on staffroom tables, or pinned to noticeboards where there is general access unless there is a legal reason to do so and/or relevant consents have been obtained. Staff should take particular care if documents have to be taken outside of school.
- 5.4 The physical security of buildings and storage systems shall be reviewed on a regular basis. If you find the security to be insufficient, you must inform the Headteacher as soon as possible. Increased risks of vandalism and/or burglary shall be taken into account when assessing the level of security required.
- 5.5 The Trust will carry out regular checks of the buildings and storage systems to ensure they are maintained to a high standard.
- 5.6 The individual schools have their own security systems to minimise the risk of unauthorised people from entering the school premises.
- 5.7 The schools close the school gates during certain hours to prevent unauthorised access to the building. An alarm system is set nightly.
- 5.8 CCTV cameras are in use at the schools and monitored by key staff delegated by the Headteacher.
- 5.9 Visitors should be required to sign in at the school Reception, accompanied at all times by a member of staff and never be left alone in areas where they could have access to confidential information.

6 Computers and ICT – Responsibilities of the ICT Team and the Leadership Team

- 6.1 The ICT Team, in conjunction with the Leadership Team, shall be responsible for the following:

- ensuring that all IT systems are assessed and deemed suitable for compliance with the school's security requirements;
- ensuring that IT security standards within the school are effectively implemented and regularly reviewed, working in consultation with the school's management and reporting the outcome of such reviews to the school's management;
- ensuring that all members of staff are kept aware of this policy and or all related legislation, regulations and other relevant rules, whether now or in the future including, but not limited to, the GDPR and Computer Misuse Act 1990.

6.2 Furthermore, the ICT Team, in conjunction with the Leadership Team, shall be responsible for the following:

- assisting all members of staff in understanding and complying with this policy;
- providing all members of staff with appropriate support and training in IT security matters and use of IT systems;
- ensuring that all members of staff are granted levels of access to IT systems that are appropriate for each member, taking into account their job role, responsibilities and any special security requirements;
- receiving and handling all reports relating to IT security matters and taking appropriate action in response (including, in the event that any reports relate to personal data, informing the DPO);
- taking proactive action, where possible, to establish and implement IT security procedures and raise awareness among members of staff;
- monitoring all IT security within the school and taking all necessary action to implement this policy and any changes made to this policy in future;
- ensuring that regular backups are taken of all data stored within the IT systems at regular intervals and that such backups are stored at a suitable location offsite.

7 Responsibilities – Members of staff

- 7.1 All members of staff must comply with all relevant parts of this policy at all times when using the IT systems.
- 7.2 Computers and other electronic devices should be locked when not in use to minimise accidental loss or disclosure.
- 7.3 You must immediately inform the Headteacher and DPO of any and all security concerns relating to the IT systems which could, or has led to, a data breach as set out in the General Data Protection Regulation policy.
- 7.4 Any other technical problems (including, but not limited to, hardware failures and software errors) which may occur on the IT systems shall be reported to a member of the Leadership Team immediately.
- 7.5 You are not entitled to install any software of your own without the approval of the Trust's Network Manager. Any software belonging to you must be approved by the Trust's Network Manager and may only be installed where that installation poses no security risk to the IT systems and where the installation would not breach and licence agreements to which that software may be subject. Prior to installation of any software onto the IT systems, you must obtain written permissions by the Trust's Network Manager. This permission must clearly state which software you may install, and onto which computer(s) or device(s) it may be installed.

7.6 Physical media (eg USB memory sticks or disks of any kind) may not be used for transferring files. The Trust Network Manager or individual school's Network Manager's approval must be obtained prior to transferring of files using cloud storage systems.

7.7 If you detect any virus this must be reported immediately to the ICT Team (this rule shall apply even where the anti-virus software automatically fixes the problem).

8 Access security

8.1 All members of staff are responsible for the security of the equipment allocated to, or used by, them and must not allow it to be used by anyone other than in accordance with this policy.

8.2 The Trust has a secure firewall and anti-virus software in place. These prevent individuals from unauthorised access and to protect the Trust's network. The Trust also teaches individuals about e-safety to ensure everyone is aware of how to protect the Trust's network and themselves.

8.3 All IT systems (in particular mobile devices) shall be protected with a secure password or passcode, or such other form of secure log-in system as approved by the ICT Team. Biometric log-in methods can only be used if approved by the ICT Team.

8.4 All passwords must, where the software, computer, or device allows:

- Be strong and secure. In line with National Cyber Security Centre (NCSC) guidance, we recommend using three random words to create memorable but secure passwords.

- Multi-factor authentication (MFA) should be enabled wherever possible for additional security.

- Not be reused across different systems or services.

- Not be obvious or easily guessed (e.g. birthdays or other memorable dates, memorable names, events, places, etc).

- Be changed immediately if there is any suspicion of compromise.

Note: Mandatory regular password changes are no longer recommended by the NCSC unless there is evidence of compromise, as this practice can lead to weaker passwords being chosen.

Passwords must be kept confidential and must not be made available to anyone else unless authorised by a member of the Leadership Team who will liaise with the Trust Network Manager as appropriate and necessary. Any member of staff who discloses his or her password to another employee in the absence of express authorisation will be liable to disciplinary action under the Trust's Disciplinary policy. Any member of staff who logs on to a computer using another member of staff's password will be liable to disciplinary action up to and including summary dismissal for gross misconduct.

If you forget your password, you should notify the ICT Team and a member of the Leadership Team to have your access to the IT system restored. You must set up a new password immediately upon the restoration of access to the IT system.

You should not write down passwords if it is possible to remember them. If necessary, you may write down passwords provided that you store them securely (eg in a locked drawer or in a secure password database). Passwords should never be left on display for others to see. Computers and other electronic devices with displays and user input devices (eg mouse, keyboard, touchscreen, etc)

shall be protected with a screen lock that will activate after a period of inactivity. You may not change this time period or disable the lock.

8.5 All mobile devices provided by the school shall be set to lock, sleep, or similar, after a period of inactivity, requiring a password, passcode or other form of log-in to unlock, wake or similar. You may not alter this time period.

8.6 Staff should be aware that if they fail to log off and leave their terminals unattended they may be held responsible for another user's activities on their terminal in breach of this policy, the Trust's General Data Protection Regulation policy and/or the requirement for confidentiality in respect of certain information.

9. Data security

9.1 Personal data sent over the Trust network will be encrypted or otherwise secured.

9.2 All members of staff are prohibited from downloading, installing or running software from external sources without obtaining prior authorisation from the Trust Network Manager or individual school's Network Manager who will consider bona fide requests for work purposes. Please note that this includes instant messaging programs, screen savers, photos, video clips, games, music files and opening any documents or communications from unknown origins. Where consent is given, all files and data should always be virus checked before they are downloaded onto the school's IT system.

9.3 You may connect to your own devices (including, but not limited to, laptops, tablets and smartphones) to the school's Wi-Fi provided that you follow the school's requirements and instructions governing this use. All usage of your own device(s) whilst connected to the school's network, or any other parts of the IT system, is subject to all relevant school and Trust policies (including, but not limited to, this policy). The Headteacher may at any time request the immediate disconnection of any such devices without notice.

9.4 Staff must not enter personal or sensitive data into unauthorised generative AI tools or chatbots (such as ChatGPT, Microsoft Copilot, or Google Gemini) without prior authorisation from the DPO and Trust Network Manager. Any unauthorised use of such tools with Trust data will be treated as a data breach and may result in disciplinary action. Approved AI tools and their permitted uses will be communicated to staff by the ICT Team.

9.5 Bring Your Own Device (BYOD)

The Trust recognises that staff may wish to use personal devices for work purposes. The following rules apply:

- Personal devices may only be connected to the Trust's guest Wi-Fi network, not the main staff network, unless specifically authorised by the Trust Network Manager

- Personal devices must not be used to access, store, or process Trust data unless specifically authorised and appropriate security measures are in place

- Any personal device used for Trust purposes must have:

- Up-to-date operating system and security patches

- Password/passcode protection enabled

- Anti-virus software installed (where applicable)

- The Trust reserves the right to request disconnection of any personal device at any time

- Staff are responsible for ensuring their personal devices comply with this policy when used for Trust purposes

10. Electronic storage of data

10.1 All portable data, and in particular personal data, should be stored on encrypted drives using methods recommended by the ICT Team.

10.2 Data must not be stored electronically on physical media (such as USB drives, external hard drives, or CDs/DVDs) without prior authorisation from the Trust Network Manager or individual school's Network Manager. Where authorised, all physical media must be encrypted and logged.

10.3 Staff must not store any personal data on any mobile device (including smartphones, tablets, or laptops) unless:

- The device is Trust-owned and approved for this purpose
- The device has appropriate encryption enabled
- Prior authorisation has been obtained from the Trust Network Manager or individual school's Network Manager
- The storage is necessary for legitimate work purposes and complies with the Trust's GDPR policy

Personal devices must not be used to store Trust data under any circumstances.

10.3 Data may only be stored on the school's computer network in order for it to be backed up. All electronic data must be securely backed up by the end of each working day and is done by Automated Processing through LGFL.

11. Home working

11.1 You should not take confidential or other information home without prior permission of the Headteacher, and only do so where satisfied appropriate technical and practical measures are in place within your home to maintain the continued security and confidentiality of that information.

11.2 When you have been given permission to take confidential or other information home, you must ensure that:

- the information is kept in a secure and locked environment where it cannot be accessed by family members or visitors;
- all confidential material that requires disposal is shredded or, in the case of digital material, securely destroyed, as soon as any need for its retention has passed.

11.3 When working remotely, staff must:

- Only access Trust systems through approved secure methods (such as VPN connections where required)
- Ensure that screens are not visible to others when working in public spaces
- Use secure Wi-Fi connections and avoid public Wi-Fi networks when accessing sensitive data
- Lock devices when stepping away, even briefly
- Follow all other provisions of this policy as if working on Trust premises

12. Communications, transfer, internet and email use

- 12.1 When using the school's IT systems, you are subject to, and must comply with, the Trust's Acceptable Use of ICT Policy.
- 12.2 The trust works to ensure the systems protect pupils and staff and are reviewed, and improved, regularly.
- 12.3 If staff or pupils discover unsuitable sites, or any material which would be unsuitable, this should be reported immediately to a member of the Leadership Team and or the DSL.
- 12.4 Regular checks are made to ensure that filtering systems are appropriate, effective and reasonable, and that users access only appropriate material as far as possible. While we implement robust filtering and monitoring systems in line with Keeping Children Safe in Education (KCSIE) requirements, it is not always possible to guarantee that all inappropriate material will be blocked. The Trust will take all reasonable steps to protect users but cannot accept liability for material accessed despite these safeguards being in place.
- 12.5 All personal information and, in particular, special category data (sensitive personal information) and confidential information, must be encrypted before being sent by email or transferred electronically. Where physical transfer is necessary, use tracked delivery services.

Fax machines must not be used to send personal or confidential information due to security risks. If there is an exceptional need to use fax, prior authorisation must be obtained from the DPO and you must verify the recipient will be present to receive the transmission immediately.

- 12.6 Postal, DX, fax, email addresses and numbers should be checked and verified before you send information to them. In particular, you should take extra care with email addresses where auto-complete features may have inserted incorrect addresses.
- 12.7 You should be careful about maintaining confidentiality when speaking in public places. You should make sure to mark confidential information 'confidential' and circulate this information only to those who need to know the information in the course of their work for the school. Personal or confidential information should not be removed from the school without prior permission from the Headteacher, except where the removal is temporary and necessary. When such permission is given, you must take all reasonable steps to ensure that the integrity of the information and the confidentiality are maintained. You must ensure that the information is:
 - not transported in see-through or other unsecured bags or cases;
 - not read in public places (eg waiting rooms, cafes, trains, etc);
 - not left unattended or in any place where it is at risk (eg in car boots, cafes, etc).

13. Reporting security breaches

- 13.1 All concerns, questions, suspected breaches or known breaches shall be referred immediately to the DPO. All members of staff have an obligation to report actual or potential data protection compliance failures.
- 13.2 When receiving a question or notification of a breach, the DPO shall immediately assess the issue, including, but not limited to, the level of risk associated with the issues, and shall take all steps necessary to respond to the issue.
- 13.3 Members of staff shall, under no circumstances, attempt to resolve an IT security breach on their own, without first consulting the DPO. Any attempt to resolve an IT security breach by a member of staff must be under the instruction of, and with the express permission of, the DPO.

13.4 Missing or stolen paper records or mobile devices, computers or physical media containing personal or confidential information should be reported immediately to the DPO.

13.5 All IT security breaches shall be fully documented.

13.6 Full details on how to notify of data breaches are set out in the General Data Protection Regulation policy.
